

**DECISION NO 28 of 11.06.2020 regarding the proposal of some necessary relaxation measures in the current epidemiological context, applicable starting with 15.06.2020**

The National Committee for Emergency Situations adopts this DECISION:

Art.1 The persons arriving from the countries established on the basis of the analysis performed by the National Institute of Public Health, approved by decision of the National Committee for Emergency Situations, are exempted from the quarantine / isolation measure.

(2) The persons coming to Romania from the countries that are the object of the quarantine / isolation exception provided in par. (1), but who, before leaving the respective country, did not stay in its territory for at least 14 days, enter quarantine / isolation at the declared dwelling / location, together with the roommates, including the family / relatives, as the case may be.

(3) Persons who have either left Romania and spend a period of less than 14 days in another country exempted from the quarantine / isolation measure, or have spent a period of at least 14 days cumulatively in countries exempted from the quarantine / isolation measure enters quarantine / isolation upon entry into Romania.

Art.2 The persons entering Romania for the performance of medical activities are exempted from the measure of isolation / quarantine.

Art.3 The number of persons who do not live together and who can participate in recreational and sports activities carried out outdoors, respectively cycling, hiking, running, rowing, mountaineering, hunting, fishing and other recreational and sports activities carried out in open air, under the conditions established by joint order of the Minister of Health, as the case may be, with the Minister of Youth and Sports, the Minister of Environment, Waters and Forests or the Minister of Agriculture and Rural Development.

Art.4 (1) The private events in closed spaces can be organized with the participation of a maximum number of 20 people.

(2) Private events in open spaces can be organized with the participation of a maximum number of 50 people.

Art.5 The number of persons who do not belong to the same family and may circulate or form pedestrian groups is increased to 6.

Art.6 Flights to and from countries for which persons arriving in Romania are exempted from the quarantine / isolation measure, established by the National Institute of Public Health and approved by the National Committee for Emergency Situations, may be resumed.

Art.7 (1) The activities of retail sale of products and services in the shopping centers where several economic operators carry out their activity are resumed.

(2) Inside the shopping centers provided in par. (1), it is not allowed:

a) the activity of restaurants, cafes or other such public places, except for those arranged outside buildings, in the open air, ensuring a minimum distance of 2 meters between tables and no more than 4 people who are not members of the same family at a table.

b) operation of playgrounds, game rooms and cinemas.

Art.8 The obligation of the economic operators that carry out gambling activities, personal care, tourist reception with accommodation functions, as well as work activities in offices with common spaces in open system, to comply with the prevention norms established by common order is established. of the Minister of Economy, Energy and the Environment and of the Minister of Health.

Art.9 The activity of the economic operators carrying out activities of outdoor swimming pools, outdoor swimming pools or sports / fitness halls is resumed, with the obligation to comply with the prevention norms established by joint order of the Minister of Youth and Sports and the Minister of Health. they can carry out their activities.

Art.10 The activity of the economic operators carrying out spa treatment activities is resumed, with the obligation to respect the prevention norms established by order of the Minister of Health.

Art.11 It is allowed to carry out activities in nurseries, kindergartens and after-school during the summer vacation, under the conditions established by joint order of the Minister of Education and Research, the Minister of Health and the Minister of Labor and Social Protection.

Art.12 This decision is communicated to all components of the National Emergency Management System, for implementation by order and administrative acts of their leaders.
