

The National Committee for Emergency Situations adopts the following

DECISION

Art.1 (1) Starting with June 1, it is allowed to organize and conduct outdoor sports competitions, without spectators, in compliance with the protection measures established by the joint order of the Minister of Youth and Sports and the Minister of Health, issued pursuant to art. 43 and of art. 71 para. (2) of Law no. 55/2020.

(2) As from 1 June, the organization and development of indoor sports, professional training activities for professional athletes and sports competitions, without the participation of spectators, shall be organized and carried out in indoor or outdoor pools, in compliance with the health protection measures established by the joint order of the Minister of Youth and Sports and the Minister of Health, issued pursuant to art. 43 and of art. 71 para. (2) of Law no. 55/2020.

(3) Starting with June 1, it is allowed to carry out, by professional athletes, the physical training activities in closed spaces, in compliance with the rules of distance between participants, so as to ensure a minimum of 7 sqm / person and in compliance with the health protection measures established by the joint order of the Minister youth and sports and the Minister of Health, issued pursuant to art. 43 and of art. 71 para. (2) of Law no. 55/2020.

(4) The measures provided in par. (1) and (3) do not apply to training activities and sports competitions in the field of contact sports.

Art. 2 Starting with June 1, it is allowed to organize and conduct shows, concerts, other outdoor cultural events, as well as public and private festivals, with the participation of up to 500 spectators with seats at a distance from minimum 2 meters, relative to each other, wearing a protective mask and compliance with the conditions established by the joint order of the Minister of Culture and the Minister of Health, issued pursuant to art. 44 and of art. 71 para. (2) of Law no. 55/2020.

Art. 3 Starting with June 1, the restrictions / interdictions regarding the movement of persons outside the locality / metropolitan area are lifted.

Art. 4 Starting with June 1, the international railway transport of persons shall be resumed by regular services, special regular services and occasional services in traffic internationally, for all flights performed by transport operators from and to Romania, in compliance with the conditions established according to art. 32, 34 and 37 of Law no. 55/2020.

Art. 5 Starting with June 1, the international road transport of persons is resumed through regular services, special regular services and occasional services in international traffic, for all flights performed by transport operators from and to Romania, in compliance with the conditions established according to art. 32, 35 and 37 of Law no. 55/2020.

Art. 6 Starting with June 1, it is allowed to prepare, market and consume food and alcoholic and non-alcoholic beverages in special spaces intended to be arranged outside buildings, in the open air, ensuring a minimum distance of 2 m between tables and the participation of a maximum of 4 people at a table, if they are from different families, and in compliance with health protection measures established by joint order of the Minister of Health. , the Minister of Economy, Energy and Business

Environment and the President of the National Sanitary Veterinary and Food Safety Authority, issued pursuant to art. 71 para. (2) of Law no. 55/2020.

Art. 7 Starting with June 1, the access of people on the beaches is made only with the mandatory provision of sunbeds for each of the persons present, ensuring a minimum distance of 2 m between the sunbeds that are used by people from different families and in compliance with the rules of prevention established by joint order of the Minister of Economy, Energy and Business Environment, the Minister of Health and the Minister of Environment, Water and Forests, issued pursuant to art. 71 para. (2) of Law no. 55/2020.

Art. 8 Starting with June 1, it is allowed to organize drive-in shows, the occupants of a car being members of the same family, health protection measures being established by joint order of the Minister of Culture and the Minister of Health, issued under Art. . 71 para. (2) of Law no. 55/2020.

Art. 9 This Decision is communicated to all components of the National Emergency Management System for implementation by order and administrative acts of their leaders.
